



This is a kind of new energy high clean gasoline containing additives agent's composition and weight percentage as follows; gasoline antiknock making agent 5%, ant-adhesive agent 10%, cleaning dispersant agent 12%, Metal purification agent 7%, Coagulant agent 21%, anticorrosive agent 8%, Accelerant agent 5% and gasoline composite agent 10%. The new energy high clean gasoline of the present invention, need not send motivation elsewhere for petrol engine, not damage engine, combustion efficiency is good, the technical indicator of product, respectively reaches the methanol gasoline standard of M15, M20, M25 and M30. Tail gas always discharge is better than European Union Emission standard, and saves fossil energy 10% - 15%. New energy high clean gasoline is the clear energy sources of global energy-saving and emission-reduction.

**(54) Title of Invention: A JET SPRINKLER IRRIGATION DEVICE**

**(57) Abstract:** A sprinkler jet irrigating device is provided in this invention. The sprinkler jet irrigating device, comprises: a concave washer for distributing water in the form of spray like rain fall; a plug (IPs) with a hole to allow the water to pass with a pressure; a bolt with sharpened locked nuts used to hold a washer; a socket used to connect plug and stand pipe; and a hooked nut which stabilizes the bolts that hold washer. The sprinkler jet irrigating device's plug is of ips material with diameter of ½ inch and a hole of 8mm. The bolt has diameter of 6mm and has no rubber seal at the top and in this way, it reduces costs for replacement of the sealed rubber. When water under high pressure hits the concave washer at the top of the sprinkler head, it sprays and fall like rainfall to irrigate the desired area.

**(57) Abstract:** Farm Express Sprayer, is an electronic advanced Knapsack sprayer. It's a multi-nozzle spraying equipment designed mainly for use in the agricultural sector and other activities that need spraying. Ideally is to design a simple product for use by peasants in rural areas in Tanzania. This arises from the fact that agriculture is the basic industry that employs over 70% of people in rural areas in Tanzania. The current innovation will center on the motorised shoulder carried sprayer and sprayers to be mounted on motor cycles. Both of them will use Direct Current (DC) pumps to simplify work and low-cost source of power in contrast to the manual sprayer that consumes time and fatigue and moreover in this development is the use of the motor cycle to simplify the work and create job opportunities.
